#### 147 ENFORCEMENT ISSUES

Cllrs were very disappointed to receive an email from Natural England, Enforcement Team stating 'Natural England's enforcement investigation of both the cases referred to as "Catcott Broad Drove" and "Westhay Broad Drove" have been concluded and we have referred this back to our local Area team, Wessex, with the view that going forward they should be in contact with the local planning authority. We would also suggest that any further information akin to the below should be referred to the local planning authority for investigation as they are attributed more to a potential breach in planning.'

New Enforcement Officer at Somerset - North has visited Westhay Broad Drove regarding horsebox at Rosebank, Catcott Broad Drove, but will take no further action at the moment as it is no longer parked on the site. He noticed mobile home on the site further along. History of this and other parts of the site have been sent to him.

### 148 TRAFFIC THROUGH THE VILLAGE AND ROAD MARKINGS

SID is currently in Catcott Broad Drove.

Cllrs agreed to purchase an additional bracket making one for each pole. This will avoid having to remove the bracket when changing location of the SID.
